

## California AB 1305 Disclosure Statement

Berkshire Hathaway Energy Company ("Berkshire Hathaway Energy," "we," "our") is required under California's *Voluntary Carbon Market Disclosures Act*, California Health and Safety Code §44475 *et seq*. (the "VCMDA"), to update our website disclosures if we make certain sustainability-related claims and/or sell, market, purchase or use voluntary carbon emissions offsets in California. Section 44475.1 applies to entities that purchase or use voluntary carbon offsets in the state of California. Berkshire Hathaway Energy and its subsidiaries do not purchase or use voluntary carbon offsets in California. Section 44475.2 applies to entities that make emissions reduction claims in the state of California. Berkshire Hathaway Energy's emissions reduction claims are subject to Section 44475.2.

Our emissions reduction claims address greenhouse gases directly emitted from existing electric generating units (i.e., power plants) owned and operated by Berkshire Hathaway Energy's subsidiaries as of 2021, and greenhouse gas emissions associated with specified market purchases by Berkshire Hathaway Energy's subsidiaries. Our subsidiaries work with their regulators to implement state policies that protect the energy and economic needs of their constituents. Accordingly, our emissions reduction claims are based on actions that can be done in a manner our customers can afford, our regulators will allow and technology advances support.
